## 3. Scope of Agreement

This Agreement applies to all orders placed with Eliteazure® ("Seller"). By executing this Agreement, checking the acceptance box, and submitting payment, the purchaser ("Buyer") agrees to all terms herein.

## 4. Custom & Made-to-Order Products

All Eliteazure® products are custom-manufactured and made to order. Due to the customized nature of the products, strict payment, cancellation, and modification policies apply.

## 5. Order Process & Communication

Eliteazure® follows a clear and transparent order process designed to ensure accuracy and timely communication:

- 1) Buyer selects the desired product and design options.
- 2) Buyer reviews and executes this Sales Agreement.
- 3) Buyer submits the required initial payment.

Production and delivery typically require approximately two (2) to four (4) months from order placement. Eliteazure® will maintain timely and professional communication, keeping Buyer informed of order status, production progress, and anticipated delivery timelines. A delivery date will be communicated in advance.

## **6. Payment Terms**

One hundred percent (100%) payment in full is required prior to manufacturing. Accepted payment methods include ACH transfer, wire transfer, check, or credit card. Credit card payments are subject to an additional three percent (3%) convenience fee.

## **7. Pricing, Taxes & Price Lock**

All quoted prices are subject to change without notice prior to order execution due to market volatility, tariff adjustments, material availability, or transportation costs. Prices are locked only after this Agreement is executed and full payment is received. Buyer is responsible only for applicable sales taxes and delivery fees.

## **8. Changes, Adjustments & Cancellations**

Buyers may request changes, adjustments, or cancellations within twenty-four (24) hours of execution and payment. After the 24-hour period, orders are considered final. However, Eliteazure® understands that project needs may evolve. If production timing permits, Seller will attempt to accommodate requested changes; however, changes are not guaranteed.

## **9. Production & Lead Time**

Eliteazure® products are manufactured to order. Estimated production lead time is approximately two (2) to four (4) months from order execution. Lead times are estimates only and are not guaranteed.

## **10. Delivery, Shipping & Risk of Loss**

Delivery dates are estimates only. Risk of loss transfers to Buyer upon shipment or delivery. Buyer must inspect materials upon receipt and report visible damage or discrepancies within forty-eight (48) hours.

## **11. Natural Stone Variations**

Stone is a natural material. Variations in color, shade, texture, thickness, and veining are inherent and shall not be considered defects.

## **12. Limitation of Liability 25 years**

Seller shall not be liable for indirect, incidental, installation or consequential damages. Seller's total liability shall not exceed the total amount paid by Buyer. Buyers are encouraged to review Eliteazure®'s Limited Liability Policy available in the Resources section of Seller's website, which is incorporated herein by reference.

## **13. Force Majeure**

Sellers shall not be liable for delays or failure to perform resulting from events beyond its reasonable control.

## **14. Governing Law**

This Agreement shall be governed by and construed in accordance with the laws of the State of Florida.

## **15. Confidentiality**

Both parties acknowledge that during the course of this Agreement, each may obtain confidential information regarding the other party's business. Both parties agree to treat all such information and the terms of this Agreement as confidential and to take all reasonable precautions against disclosure of such information to unauthorized third parties during and after the term of this Agreement.

## **16. Acceptance & Electronic Signature**

By executing this Agreement, Buyer acknowledges that they have read, understood, and agreed to be legally enforceable.
